IFCS is facing quite a few thrilling challenges! It is a privilege to be given the opportunity to serve the Federation in the role of President at such a time, and I very much look forward to collaborating with the **IFCS** Executive Committee, the IFCS Council and the broad community of researchers in classification and data analysis to move our research and interactions to a next level.

Of course, I would also like to take the opportunity to warmly thank my predecessor, Geoff McLachlan, for the involvement and the dedication with which he piloted the federation through the past two years. I look forward to continuing the collaboration with him on the Executive Committee. Otherwise, I am also most happy that Geoff accepted to act as convener of an IFCS thematic session at the forthcoming Compstat conference in Limassol, Cyprus.

Thanks also go to André Hardy for his tireless efforts to produce the IFCS Newsletter during his two terms as IFCS Publications Officer.

Finally, I would like to convey special thanks to Buck McMorris, who left the IFCS Executive Committee after serving on it for six consecutive years. However, as has already been mentioned in the previous Newsletter, Buck will retain some links with the Executive Committee as he has been co-opted to be a special advisor on the expansion by the Federation into membership regions. I look very much forward to working with Buck on this. Otherwise, during the past few months, we received several very enthusiastic and encouraging messages that imply a significant expansion of the Federation in several directions could be feasible. I hope to be able to give you more information on this in future issues of this Newsletter.

It is further my pleasure to congratulate Maurizio Vichi on being elected the next IFCS President. Maurizio has a long record of service in the Federation and on the IFCS Council, and has been a dynamic President of SIS. The Federation is fortunate to have him now during six years on the Executive Committee (two years as President-Elect, two years as President, and two years as Past President).

Moreover, I am also very happy to welcome Paul McNicholas on the Executive Committee upon his election as the new IFCS Publications Officer. In the new millennium, we will have to come up with several new publication channels and initiatives, and I trust that with Paul the publication challenges facing the Federation are in very good hands.

One of the major IFCS initiatives in the coming two years will be the biannual conference of the Federation, IFCS-2013. I am delighted that the Department of Methodology and Statistics of Tilburg University, in cooperation with the Dutch/Flemish Classification Society (VOC), has composed an excellent bid for the organization of this conference that has been enthusiastically approved by the IFCS Council. Personally, I have already had several interactions with the local organizers, Jeroen Vermunt and Andries van der Ark, and I must say that I am most impressed by the professionalism and sound pragmatism with which they are dealing with a very demanding

conference organization. In another place of this Newsletter you will find more information about IFCS-2013 along with a first call for papers. I trust that you will mark the conference venue (Tilburg, The Netherlands) and the conference dates (July 14-17, 2013) in your calendar, and I look forward to meeting all of you in Tilburg in July 2013!

At the occasion of IFCS-2013, the Federation will award again a small number of prizes (named after the late Chikio Hayashi) to (relatively) young, promising researchers on the basis of a solid scientific track record and impact on classification research. The federation considers these prizes most important, as they may give significant support to the winners in the development of their academic career. I am very proud that once more a group of very distinguished scholars has accepted to act as the Chikio Hayashi Awards committee that will evaluate the applications for the prizes: Edwin Diday (University of Paris-Dauphine), Sylvia Frühwirth-Schnatter (Vienna University Economics and Business). James Ramsav (McGill University), and Michel Wedel (chair; University of Maryland). Elsewhere in this Newsletter you will find more information on the application procedure. I would like to strongly encourage all promising, young researchers in the areas of classification and data analysis to submit an application.

Finally, I would like to point out that nowadays new methods, algorithms, and data-analytic devices are very often being proposed in the classification domain without adequate comparison with current best practices or gold standards, and without sufficient evidence of good performance on benchmark data sets. This practice is prohibitive as it hampers the building of a cumulative body of knowledge. The standards within the classification domain are in this regard somewhat inferior to those in a few other disciplines (including medicine and parts of the engineering sciences) that have a more established benchmarking culture. Within the Federation, we want to answer this challenge and at a meeting in Frankfurt, the IFCS Council approved a proposal from the Executive Committee to launch a project on this. This project includes the establishment benchmarking task force, the current composition of which is: Christophe Biernacki, Bernd Bischl,

Nema Dean (chair), Christian Hennig, Friedrich Leisch, Geoff McLachlan, Douglas Steinley, and Iven Van Mechelen. The task force has already met a couple of times and I very much look forward to seeing preliminary results during the months. Moreover, few next representatives of the committee agreed to contribute to an IFCS invited session on benchmarking (scientifically sponsored by both IFCS and IASC) at the World Statistics Conference (ISI) in Hong Kong, August 2013. Indeed, the Federation is facing quite a few thrilling challenges!

# Call for Papers IFCS-2013 July 14-17, 2013 Tilburg, The Netherlands

### **Conference Setup**

The 2013 conference of the International Federation of Classification Societies (IFCS) will be held at Tilburg University, The Netherlands from July 14 to July 17, 2013. The conference theme will be 'United through Ordination and Classification'.

On July 14, preconference workshops will be held. The conference itself starts on July 15 in the morning, and will close on July 17 with a full day conference program and a conference dinner. The conference will include a president's invited session and a presidential address, keynote presentations, invited presentations, invited and contributed symposia, and oral and poster presentations.

The opening session will further feature the presentation of the Chikio Hayashi Awards, which are scientific prizes for young researchers with promising track records in the areas of classification and data analysis, as a support of their professional career; for 2013,. The members of the Awards Committee are: Michel Wedel (chair), Edwin Diday, Sylvia Frühwirth-Schnatter and James Ramsay.

### Tilburg

Tilburg is a lively student city - with 200,000 inhabitants of which 30,000 are students! When you have finished your studies for the day, a short trip to the city centre takes you to theatres, cinemas, museums, restaurants, pubs, nightclubs and a concert hall – with enough variety for every taste. Or if you want to go further, other cities such as Amsterdam, Brussels, Paris and Cologne are within easy reach of Tilburg. Festivals are

# Chikio Hayashi Awards Program

Researchers who want to apply for a CHA award, for the occasion of the IFCS'13 Conference (July 14th through July 17th 2013 in Tilburg, The Netherlands), are invited to submit their application to the Chair of the Awards Committee (Dr. Michel Wedel, attention of Carol Cron e-mail address: ccron@rhsmith.umd.edu).

The award committee consists of Edwin Diday Paris-Dauphine), (University of **Sylvia** Frühwirth-Schnatter University (Vienna Economics and Business). James Ramsav (McGill University) and Michel Wedel (University of Maryland).

The Chikio Hayashi award is given to young, promising researchers on the basis of their scientific track record and impact on Classification Research. Applicants are requested to submit a one-page statement of expertise and impact (this form), a recent CV (pdf), and three selected published papers (pdf). The statement of expertise and impact needs to refer to these papers and include a recent dated Web-of-Science citation count for each.

All candidates must be under the age of 35 years at the time of the conference and <u>need to be</u> authors of a paper to be presented at the IFCS Conference.

All candidates will be notified the evaluation results no later than May 30<sup>th</sup>, 2013.

# **IFCS-sponsored Courses:** Call for Applications

The IFCS Council has adopted a proposal from the IFCS Executive Committee to sponsor each year one course on IFCS-related topics. All individual members of the IFCS member societies are invited to consider submitting a proposal. Below, one may find the rules for sponsoring as approved by the IFCS Executive Committee.

- Eligible for sponsoring by IFCS are courses:
  - o open for an international audience, in the English language, on topics within the domains of classification and data analysis as those may be typically encountered in the mainstream of IFCS conferences
  - o that are supported by at least two IFCS member societies (as made clear by the explicit mentioning of members from those societies in the organizing committee)
  - o that are attended by participants from at least two IFCS member societies
  - o that are non-profit (in the sense that no financial gain is aimed at by the organizers)
- Pre IFCS conference workshops are excluded from sponsoring.

- Sponsoring can only be used to cover costs directly pertaining to the organization of the course (e.g., for lecture rooms, announcements, travel costs, etc.), herewith excluding financing of teachers (except for a reimbursement of expenses). In addition to financial sponsoring, IFCS will mention the course on its website and in other media, if possible. Conversely, in all announcements of the course, IFCS has to be mentioned as sponsor.
- Requests for sponsoring shall be made to the President of IFCS by the organizer of the course, at least 6 months before the course starts. The request should contain:
  - A description of the aim of the course
  - o A preliminary program of the course
  - A list of the IFCS member societies involved in the organization of the course as well as the composition of the organizing committee, which should include an IFCS Council member from a society not involved in the organization of the course
  - A description of the size and kind of the intended audience
  - A detailed budget for the course, including the height of the fees, and the amount requested from IFCS
- Decisions on sponsoring shall be made by the IFCS Executive Committee.
- Each budgetary year, only one course can be sponsored, with a maximum amount of \$1000. In this respect, the dates of the course determine with which budgetary year the course is associated.
- If the local situation of the course organizers allows to apply for matching funds, the organizers are encouraged to make use of this possibility; if needed, upon request of the organizers, the IFCS Executive Committee will state that IFCS sponsoring is granted conditional upon the awarding of matching funds.
- The sponsoring is paid after the course, upon receipt of a report on the course (mentioning at least the topics on the program, the number of participants and their countries of residence, as well as the number of days the course lasted), and a full financial account.

### (II) The 4th Japanese-German Symposium on Classification (JGSC 2012)

JGSC 2012 was held on March 9th to 10th at Doshisha University, Kyoto Japan. symposium was organized together with the German Classification Society (GfKl). The 1st Japanese-German Symposium on Classification was held in 2005 in Tokyo. Since then, the 2nd German-Japanese Workshop (Berlin, 2006) and the 3rd German-Japanese Workshop (Karlsruhe, 2010) have been actively organized by German and Japanese researchers in classification and related fields. The symposium included 33 talks in eight sections in which 11 German participants with 50 Japanese participants discussed and shared their insights of data analysis. This symposium aroused great interest as the research papers of the 1st and the 2nd symposium were published by Springer-Verlag in a book entitled 'Studies in Classification, Data Analysis, and Knowledge Organization'. The research papers of the 3rd and the 4th Symposium will also be published by Springer-Verlag.

### **JOCLAD 2013 - Call for Participation**

The XX Annual Meeting of the Associação Portuguesa de CLassificação e Análise de Dados (CLAD), JOCLAD 2013, will be held on April 10-13 2013 at the Universidade do Minho - Campus de Azurém. The web site of the meeting will be available soon.

#### **JOCLAD 2012**

The XIX Annual Meeting of the CLAD, JOCLAD 2012, was held on March 28-31 2012 at the Instituto Politécnico de Tomar. About 70 participants, among researchers, students and professionals, attended the conference.

The JOCLAD 2012 scientific program included four types of presentations: plenary sessions - "Data Analysis and Mining of Narrative: Supporting Search and Navigation through Pattern Recognition in Narrative" by Fionn Murtagh (Science Foundation Ireland and Department of Computer Science – University of London), "Two-mode partitioning: State of the art" by Iven Van Mechelen (Faculty of Psychology and Educational Sciences - Katholieke Universiteit Leuven), "Intuição,

Realidade, Análise de Dados e Inferência", by Carlos Agra Coelho (Faculdade de Ciências e Tecnologia - Universidade Nova de Lisboa) and "A combinação fixo+móvel nas sondagens telefónicas" by Paula Vicente (ISCTE - Instituto Universitário de Lisboa); thematic sessions – "Projectos Inovadores nas Estatísticas dos Bancos Centrais" sponsored by the Banco de Portugal, "Desafios nas estatísticas Oficiais" sponsored by the Instituto Nacional de Estatística; contributed papers and posters.
