News from CLAD

JOCLAD 2013

The XX Annual Meeting JOCLAD 2013 of the Associação Portuguesa de CLassificação e Análise de Dados, CLAD, was held on April 11-13 2013 at the Universidade do Minho – Campus de Azurém, Guimarães. About 80 participants, among researchers, students and professionals, attended the conference.

The scientific program included three invited talks (Statistical models for clustering data, by Maurizio Vichi, Sapienza Università di Roma, Italy; Estimation of labour force indicators in counties of Galicia using a multinomial mixed model, by Maria José Lombardía Cortiña,

Universidade da Coruña, Spain; and *Data analysis in the large data era*, by Ana Maria Pires, Instituto Superior Técnico de Lisboa, Portugal), two thematic sessions (organized by Instituto Nacional de Estatística and Banco de Portugal), as well as contributed papers and posters.

A short course (*Métodos de reamostragem - o bootstrap*, by Conceição Amado, Instituto Superior Técnico de Lisboa) took place on April 11.

The book entitled 'CLASSIFICAÇÃO E ANÁLISE DE DADOS. Métodos e Aplicações', a recent CLAD Publication, was introduced and distributed at the JOCLAD2013 meeting. Publisher is the INE - Instituto Nacional de Estatística. Editors are Helena Bacelar-Nicolau (Universidade de Lisboa), Fernanda Sousa (Universidade do Porto) and Carlos Ferreira (Universidade de Aveiro).

"Banco de Portugal – Clad Award" for Young Researchers in the Field of Statistics

Banco de Portugal and CLAD have created the "Banco de Portugal – Clad Award" (Prémio Banco de Portugal – CLAD), to recognise the best works each year in statistical analysis produced by young researchers from statistical data published by Banco de Portugal.

The award will be first presented during the school year 2013/2014. The author of the best work in statistical analysis will receive a prize of one thousand five hundred euro and will be entitled to a six-month paid internship at Banco de Portugal.

Two further submissions may also receive honourable mentions. These researchers will be entitled to a three-month paid internship at Banco de Portugal.

Applications: The deadline for applications is 28 February 2014. Students that are at least in the second cycle of university studies (including post-graduate) may apply for the Prémio Banco de Portugal – CLAD.

Submissions must be unpublished, in scientific article format and produced in the following fields: Monetary and financial statistics; Balance of payments and international investment position statistics; Financial accounts and general government statistics; Non-financial corporation statistics in the Central Balance-Sheet Database.

Classification Society Distinguished Dissertation Award

The award is given to a dissertation demonstrating the most innovative or impressive work in theory/methodology, or the most innovative or well-developed application(s) with the proviso that the literature review has to be thorough. The winner of the 2013 Classification Society Distinguished Dissertation Award was Jeff Andrews from the University of Guelph (advisor Paul McNicholas).
